This position operates out of our Bloomington or Indianapolis office and assists with the completion of urban green infrastructure maintenance, native plant and tree installations, and ecological restoration activities. Herbicide applications to control invasive plant species will be an essential function of this position and will account for a portion of the work performed during this timeframe. Travel and overnights stays are also occasionally required. All travel time and hotels are paid and per diem is provided. Work is performed Monday through Friday and all employees average 40-50 hours per week. Eco Logic offers paid holidays on Memorial Day, July 4th, Labor Day, and Thanksgiving for all Seasonal Green Infrastructure technicians.

Principal Accountabilities

- Arrive on time, well rested, with all essential gear and personal supplies.
- Operate, load, and unload large trucks and trailers safely daily.
- Mobilize, transport, use, and maintain all tools and equipment in a safe manner.
- Utilize provided PPE, including insect repellants, in accordance with EPA and OSHA regulations.
- Operate GPS units and collect data in a standardized format on a semi-regular basis.
- Listen to and follow detailed instructions about plant and other material installation.
- Operate brush cutters, augers, and a variety of other small tools.
- Show discipline in filling out daily logs, timesheets, and other essential paperwork.
- Other duties as assigned.

Minimum Requirements

- Possess a valid driver's license and maintain a clean driving record.
- Possess or can obtain a pesticide applicators license with the Office of the Indiana State Chemist
- Knowledge of common urban weeds and Indiana Invasive plants
- Ability to lift and carry a 30 lbs. backpack sprayer for extended periods; hiking up to 12 miles a day.
- Ability to perform repetitive tasks such as lifting, digging, and hammering for extended periods.
- Ability to work in extreme weather conditions such as extreme heat, rain, and full sun.
- Ability to work with exposure to ticks, mosquitoes, poison ivy, stinging insects.
- Experienced in the field of landscaping or stormwater management [Preferred]
